SUMMARY OF MATERIAL MODIFICATIONS



MDLIVE Virtual Visits Benefit

Effective April 1, 2020, the Fund is adding a Virtual Visits benefit with MDLIVE. Both phone and video visits with a doctor or therapist will available either via a mobile app, web-based browser portal or by phone. Please see the enclosed flier for information on how to access the service on or after April 1, 2020. You will need wait until April 1, 2020 or after to register your account with MDLIVE.

The following is a summary of the MDLIVE Virtual Visits benefit:

- The service will be available for both General Medical and Mental/Behavioral Health.
- The MDLIVE Virtual Visits benefit is covered 100% by the Fund. There are no copays, deductibles, or coinsurance that will be owed by you. Eligibility and coverage under the Fund are required to use the service.
- There is no minimum age for a covered Person to use the General Medical service. The minimum age to use the Mental/Behavioral Health service is twelve (12). Covered Persons under age 18 may proceed with a MDLIVE Virtual Visit only with a parent/guardian present.
- The MDLIVE Virtual Visits benefit is only available to active Employees, Retirees not eligible for Medicare, and their spouses and Dependents. The service will not be available for Medicare-eligible retirees.²

You will be receiving new Blue Cross and Blue Shield of Illinois identification cards because the Fund is adding this benefit. There is new information about accessing the MDLIVE Virtual Visits benefit on the back of your new identification card. You can also continue to use any old identification card(s) you have.

¹Prescription drug charges resulting from medications prescribed through the MDLIVE Virtual Visits benefit will be covered under the Fund's prescription drug benefit. Services received by providers outside of the MDLIVE Virtual Visits benefit will be covered under the Fund's standard medical benefit. Copays, deductibles, and coinsurance will apply for these such drugs and services outside of the MDLIVE Virtual Visits benefit.

²For Medicare-eligible Persons, Medicare covers certain virtual visits or telemedicine. On behalf of such Persons, the Fund will process claims for such virtual visits or telemedicine which are covered by Medicare under the Fund's Medicare Supplement Plan.







Virtual Visits: Speak with a doctor or therapist — anytime, anywhere

With your virtual visits benefit, provided by Blue Cross and Blue Shield of Illinois (BCBSIL) and powered by MDLIVE, the doctor is in 24/7/365. You can see a doctor or behavioral health specialist without leaving the comfort of your own home.

Virtual visits allows you to consult an independently contracted, board-certified doctor or therapist for non-emergency situations by phone, mobile app or online video anytime, anywhere. Speak to a doctor or schedule an appointment at a time that works best for you.

- 24/7 access to an independently contracted, board-certified MDLIVE doctor
- Access via phone, online video or mobile app from almost anywhere
- Average wait time of less than 20 minutes
- If needed, get a prescription sent to your local pharmacy

There is no charge to set up your account, but you may have a charge for your visit depending on your benefit plan.

Virtual visits doctors may also send an e-prescription to your local pharmacy if necessary.

Virtual visits may not be available on all plans. Virtual visits are subject to the terms and conditions of your benefit plan, including benefits, limitations and exclusions. Non-emergency medical service in Montana and New Mexico is limited to interactive audio/video (video only). Non-emergency medical service in Arkansas and Idaho is limited to interactive audio/video (video only) for initial consultation. Service availability depends on location at the time of consultation.

MDLIVE, a separate company, operates and administers the virtual visit program for Blue Cross and Blue Shield of Illinois and is solely responsible for its operations and that of its contracted providers.

Statement of Grandfathered Status

The Trustees believe that this Plan is a "grandfathered health plan" under the Affordable Care Act, which permits us to preserve certain basic health coverage already in effect before the law was passed. As with all grandfathered health plans, our Plan does not have to include certain consumer protections of the Affordable Care Act that apply to other plans (for example, providing preventive health services without any cost sharing). However, grandfathered health plans, like our Plan, must comply with other consumer protections in the Affordable Care Act (for example, the extension of coverage for dependent children to age 26).

Contact the Welfare Trust Fund Administrative Office if you have questions about what it means for a health plan to have grandfathered status and what might cause a plan to lose its grandfathered status. The Trustees reserve the right to amend, modify, or terminate the Plan at any time.
